Notification of Change in the Closing Date of Share Transfer regarding the Change in Subsidiary

Tokyo, June 24, 2022 --- As announced in the news release issued on January 14, 2022^{*1}, Hitachi, Ltd. (TSE: 6501, "Hitachi") executed an agreement regarding the transfer of a part of shares of common stocks of Hitachi Construction Machinery Co. Ltd. ("HCM"), a consolidated subsidiary of Hitachi (the "Share Transfer") with HCJI Holdings G.K. ("JIP Consortium SPC")^{*2}.

Since the procedures and measures for approvals regarding the Share Transfer from relevant authorities have not been completed in some countries as of today, Hitachi and JIP Consortium SPC changed the scheduled closing date of the Share Transfer from June 2022 to by the end of September 2022.
